Concept Development and Experimentation (CD&E) Working Group meeting

The annual Concept Development and Experimentation (CD&E) Working Group (WG) took place over the period 12-14 March 2013 in Virginia Beach, VA, USA. The NATO ENSEC COE was represented by Ms Rasa Pazarauskiene, Expert, Doctrine and Concept Development Division.

The main purpose of the CD&E WG was to conduct the necessary technical validation of the 2014 CD&E proposals. At the same time the event offered the Nations, Centres of Excellence and other NATO Organisations the opportunity to collaborate with ACT by comparing CD&E Programmes of Work and where possible integrating national and ACT CD&E activities. In addition participants were requested to express their areas of interest to HQ SACT in order to generate discussion on possible future CD&E activities that could be of benefit to the Alliance.

COE MOU workshop

First COE MOU workshop took place in Bratislava (Slovakia) on 11-13 March. The NATO ENSEC COE was represented by Ms Renata Vaisviliene, Legal Advisor.

Following points were covered at the workshop: - The MOU amendment process is understood and any misconceptions are addressed.



Each improvement to MOUs is discussed and the rationale behind it is fully understood. - Individual MOUs will be examined and changes identified.

- Delegates identify which changes are suitable for their COE.

- Common text is agreed among delegates to implement the desired changes.

Visit of the Chief of Staff of NATO's Allied Command Transformation
